Scheduled Election

Fair Work (Registered Organisations) Act 2009

Nominations, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 16/07/2025.

Additional forms are available from the Returning Officer or from the portal <https://eemt.microsoftcrmportals.com/electoral-event-portal/current-industrial-elections/> by navigating to the specific election and clicking on the hyperlink for that election.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via one of the lodgement methods stipulated below **not later than** 4:30pm Australian Eastern Standard Time (AEST) **on** 30/07/2025.

How to lodge nominations, nominations must be lodged via one of the following methods:

By Email: A properly completed nomination form including all necessary signatures and attachments, can be scanned and submitted as a pdf file to IEBnominations@aec.gov.au

1. Emails appearing to be spam may be blocked by the AEC inbox. It is the sender's responsibility to ensure their email reaches the AEC before the nomination deadline.
2. To be received by the AEC, emails (including attachments) should not exceed 6 MB in size.

Withdrawing Nominations

Nominations cannot be withdrawn after 4:30pm Australian Eastern Standard Time (AEST) on 06/08/2025.

Candidate Statements – Branch President and Branch Secretary only

Candidates may submit an A4 information sheet to be included with ballot material. The information sheet submitted will be reproduced as received by the candidates, but the presentation may be amended for publication purposes. Only statements which comply with the Rules and received by the Returning Officer by 4:30pm (Australian Eastern Standard Time (AEST)) on 06/08/2025 can be accepted.

Voting Period

The ballot, if required, will open on 27/08/2025 and close at 10:00am Australian Eastern Standard Time (AEST) on 24/09/2025.

If the postal vote pack is not received by 08/09/2025 voters may contact the AEC to request a replacement voter pack by calling 02 9375 6366 or 03 9285 7111 or by sending an email to IEBevents@aec.gov.au. If you are on the roll of voters, a replacement ballot pack will be sent by regular mail.
